

TERMS AND CONDITIONS OF THE MASTERCARD UEFA EURO 2008™ COMPETITION

Article 1 Organisers / Duration of the competition

FOTOVISTA, a joint-stock company with a capital of 19,033,875 euros and with headquarters at 183, rue de Chevaleret, 75013 Paris (France), and listed on the *Registre du Commerce et des Sociétés de Paris* (Register of Companies and Commerce in Paris) under the number B 352 236 244 (hereafter referred to as the organising company), is organising a free competition with no purchase required on the internet and in its shops, which will run from 20/04/2008 until midnight on 20/05/2008, with a limit of one competition entry per household. Participants may win tickets for matches in the UEFA EURO 2008™, courtesy of MasterCard, the official sponsor of the UEFA EURO 2008™, as well as high-tech prizes and MasterCard - UEFA EURO 2008™ gifts in a prize draw that will be held on 02/06/2008.

Article 2 Participants

This competition is open to all adults residing in France (excluding French overseas departments and territories), Belgium, Spain, Portugal, Italy, Germany, Sweden, the Netherlands, the United Kingdom, Ireland, Luxembourg, Switzerland, the Czech Republic, Austria, Poland and Greece, except for employees of the organising company stated in article 1. Family members of employees of the organising company mentioned above may not participate in the competition.

It is specified that a person is identified by the status, surname, first name, date of birth, postcode, e-mail address and VIPix card number, where appropriate, provided by the person in question or recorded automatically.

Only one entry per household (same name, same postal address) is authorised for the entire period of the competition.

Given that a household is defined as a unit people living under the same roof, there can be only one winner per household during the period of the competition.

The organising company reserves the right to proceed with checks in the context of the application of the present article.

Article 3 Principle

1) To play this game, all participants must follow the steps below:

- Connect to the site dedicated to the competition, accessible at the following address: www.pixmania.com, between 20 April 2008 and midnight on 20 May 2008 (connection date and time in metropolitan France being proof thereof), or visit one of Pixmania's 12 shops or FOCI's 129 points of sale participating in the operation between 20 April and 20 May 2008.

- Drop the registration form into the box in any of Pixmania's 12 shops and FOCI's 129 points of sale participating in the operation, in order to be entered into the prize draw, which will take place on 02/06/2008 at the latest. Entries submitted online or by letter (sent by post before 20 May 2008 and received before the closing date of the prize draw; the postmark will be proof thereof) will automatically be entered into the prize draw.

Article 4 Description of prizes
